Science Editor: 1 Scientific quality: The manuscript describes a minireview of the imaging evaluation of the liver in oncology patients. The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: In this review, authors indicated that this study aimed to briefly review each of the imaging techniques and subsequently compare them in assessing liver metastases, including detection, characterization, diagnosis, and treatment response evaluation. The questions raised by the reviewers should be answered; (3) Format: There are 14 figures; (4) References: A total of 75 references are cited, including 20 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
