(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors focused on the expanding role for liver transplantation, updated guidelines in the use of chemotherapy, novel applications of individualized therapy targeting the specific mutation profile of tumors, and management</p>	[Y]

of malignant biliary obstruction. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 tables. (4) References: A total of 106 references are cited, including 12 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
