(1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: The review covers full of interesting observations, and clearly describes and evaluates the epidemiological and clinical characteristics of drug-induced stuttering and suggests some pathophysiological mechanisms for the adverse drug reaction. In overall, the review is crucial for further understanding the adverse effects of the drugs triggering drug-induced stuttering; (3) Format: There are 3 tables and 1 figure; (4) References: A total of 110 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
