The topic is within the scope of the WJP. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: This study constructs a spiritual care plan for advanced cancer patients. care plan may achieve good results when applied to advanced cancer patients. Overall, the study is very well designed, and the manuscript is well written. The questions raised by the reviewers should be answered; (3) Format: There are 8 tables; (4) References: A total of 33 references are cited, including no references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJP. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the

Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Psychiatry, and the manuscript is conditionally accepted.
