The present review analyzes the potential non-pharmacological stem cell therapy to treat depression based on experimental evidence published in the literature. If the authors complete the minor revision, the quality of the study will be further improved.

1. abstract: Authors need to modify the abstract by referring to the format in this journal.

2. page 3, "Pharmacological treatment for depression has been available since 1957, when imipramine, a tricyclic antidepressant, and iproniazid, a monoamine oxidase inhibitor, were released." - Sources (references) are required.

We added these two references as suggested by reviewer (references 8 and 9)

3. page 22, "Cell therapy is a promising treatment option. Its potential will only be determined through clinical trials that have

already begun to be developed." - The study was well written overall. However, the final sentence of the conclusion is awkward in context. I suggest the author to write the last sentence as an implication for future research.

Thank you for your suggestion we restructured this final sentence to reinforce the relevance to develop future research involving stem-cells and depression.

We self-cited five references that represents 5,1% of all references (n= 18). Despite the self-citation is 10% and considered we reduced three self-references involving stem-cells in other neurological diseases.
