The topic is within the scope of the WJSC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The manuscript introduces the development of CNS tumor model preparation and</p>	[Y]

application from the perspective of three-dimensional models, which is of great value. However, the overall logic of the manuscript is not clear, and it fails to intuitively reflect the associations and differences between the 3D-sphere, organoids and brain chip models. The questions raised by the reviewer should be answered; and (3) Format: There is 1 figure. (4) References: A total of 85 references are cited, including 35 references published in the last 3 years; (5) Self-cited references: There are 8 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. Please revise throughout; (4) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
