	<p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the epigenetic regulation of dental pulp stem cells and its potential in regenerative endodontics. The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is addressing an interesting point. The structure of the manuscript appears adequate and well divided in the sub-paragraphs. However, some issues should be improved. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables. (4) References: A total of 145 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
