Additionally, and based to the WJSCs guidelines a formal Language Certificate must be provided. In this purpose the manuscript needs erious languag editing provided either by a native English speaker or by a dedicated language service. The authors have not provided the Copy Right Licence Agrrement. Imporatanly, the authors must submit the Copy Right License Agreement for the current manuscript. 4. Supplementary comments: I totally agree with the comments of the reviewers. The authors must perform the revisions according to reviewer's comments in order the manuscript to be processed to the next step of the publication process. The submitted manuscript is a review study invited manuscript with ID 65221. In addition, in my opinion the authors should focus more to the clinical and preclinical data rather than historically information. Also, the author should include future clinincal trials to their manuscript. The addition of more figures, and tables featuring the upcoming clinical trials, will increase the value of the manuscript. 5. Issues raised: N/A. 6 Re-review: Required/ 7.
