The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 59 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
