The topic is within the scope of the WJG. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The authors summarized the advances in HBV</p>	[Y]

modeling reported thus far and discussed the limitations and ongoing challenges in the application of liver organoids, particularly those with multi-cellular components derived from human iPSCs. The topic is timely and adequate. However, the questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. (4) References: A total of 131 references are cited, including 40 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
