I highly appreciate the author's detailed literature review, but the length of the article is too long to be published in journals, and it is more suitable to be published as a book after expansion. If the author wants to publish this article in the journal, please reduce the length as much as possible.

The questions raised by the reviewers should be answered;
- (3) Format: There are 2 tables;
- (4) References: A total of 273 references are cited, including 52 references published in the last 3 years; and
- (5) Self-cited references: There is no self-cited reference.
