<u>Response:</u> Thank you for pointing this out. We have mentioned this concern in paragraph 5 of discussion

"Although it has been reported that transplanting small kidneys in to large recipients (donor kidney weight/ recipient body weight <2g/kg) causes hyperfiltration and results in decreased creatinine clearance and proteinuria 6-months after transplantation (11), in our patient, the single kidney graft has proved sufficient enough to keep him off renal replacement therapy and with normal serum creatinine levels as noted at 1-year post-transplant, and without proteinuria. Additionally, the second kidney from the same deceased donor was eventually implanted to a different recipient in our centre who benefited from an equally good graft function"
