(1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The manuscript was designed to compare the efficacy and safety of combination immunogenic chemotherapy of atezolizumab and bevacizumab as first-line therapy as opposed to sorafenib and atezolizumab monotherapies, for patients with advanced HCC. It is interesting. However, the questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. (4) References: A total of 24 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
