2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript describes a basic study of the impact of intrarectal chromofungin treatment on dendritic cells-related markers in different immune compartments in colonic inflammatory conditions. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors provided evidence that administration of Chromofungin (CHR: chromogranin-A 47-66) negatively regulates the development of DSS-induced colitis. Most of data shown in this data are convincing. However, the questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 7 figures. (4) References: A total of 86 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are 19 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
