The topic is within the scope of the WJV. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The word and method of this article is so concise and clear, and it has important biological significance, especially Ambisense genes located in the genome in a stacking</p>	[Y]

manner. However, it is better to provide the viral RNA sequence used in the article, which could be a link from NCBI or GISAID etc.; and (3) Format: There are 2 tables and 2 figures. (4) References: A total of 22 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published; and correctly indicating the reference source and copyrights.
