The topic is within the scope of the WJG. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: The authors show the efficacy of EUS-guided vascular interventions. It is well-written and methodologically valid. However, some minor criticisms should be</p>	[Y]

modified. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. (4) References: A total of 91 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There are 3 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
