**Science Editor:** 1 Scientific quality: The manuscript describes a systemic review (Not an editorial) of the COVID 19 pandemic in the update on the reaction attitude of the spine societies and their members. The topic is within the scope of the WJO. (1) Classification: Two Grades C; (2) Summary of the Peer-Review Report: The choice of topic is good as large data is available on managing spinal pathologies during the COVID-19 pandemic without stressing the limited manpower and resources at the same time addressing the emergency cases. Reviewing the data and provide useful points is a great task. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 29 references are cited, including 26 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
