**Science Editor:** 1 Scientific quality: The manuscript describes an Observational Study of the Covid 19 emergency and quality of life. The topic is within the scope of the WJH. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The study on a relatively small number of patients is well written, the message is clear. It would be good to know a little more references about this subject. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 1 figures; (4) References: A total of 11 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; (4) The authors need to fill out the STROBE checklist with page numbers; and (5) Sub-tables are not allowed within tables; for example, Table 1A and Table 1B. Tables in picture format are unacceptable. 6 Recommendation: Conditional acceptance.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Hepatology, and the manuscript is conditionally accepted.
