(1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: The study on a relatively small number of patients is well written, the message is clear. It would be good to know a little more references about this subject. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 1 figures; (4) References: A total of 11 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
