Science Editor: 1 Scientific quality: The manuscript describes a basic study of the Impact of stimulants on behavior and EF in children with ADHD. The topic is within the scope of the WJCP. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: This paper provides an overview on the short- and long-term impact of stimulant medications in children with Attention Deficit Hyperactivity disorder with the aim to evaluate objectively by analysis both behavior rating scales completed by parents and neuropsychological performance-based measures. The study is not novel, yet adding some important information to existing knowledge. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. (4) References: A total of 35 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
