were able to construct a five gene signature model for predicting prognosis of the patients. In page 3: correct the word 'fibre' Table 1: addd range for age and OS time. Page 9: full name of BH test Page 9: please remove this sentence "If not stated above". figures: write the full name of all abbreviations in each figure of the article. In page 10, last line in the first paragraph: the figure 2E illustrates association or correlation between genes. Please add more explanation for the correlation between the expressed genes (in fig.2E), and their relation to COAC. The resolution for figure 7B,C,D is not clear. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 10 figures. (4) References: A total of 57 references are cited, including 26 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
