Science Editor: 1 Scientific quality: The manuscript describes a scientometrics of the global research production in neonatal abstinence syndrome from 1958 to 2019. The topic is within the scope of the WJCP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors found a very good article on knowledge mapping, which analyzed and visualized the research hotspots and characteristics of neonatal abstinence syndrome in detail. However, Figure 2 is extremely asymmetric, and a lot of information is not shown; and (3) Format: There are 5 tables and 5 figures. (4) References: A total of 72 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com.
