The topic is within the scope of the WJM. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The research question you addressed is interesting. The study title accurately reflects on the contents of this paper. The abstract</p>	[Y]

summarizes what the work has described in the text and key word selection is accurate. Biostatistics used are correct reflecting on the authors' earlier experience in this field and references are up-to-date; and (3) Format: There is 1 figure. (4) References: A total of 11 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
