interesting report of graft versus host disease following liver transplantation, an occurrence that is rare, underdiagnosed and often lethal. However, some minor adjustments are necessary in the report; and (3) Format: There are 3 tables and 3 figures. (4) References: A total of 20 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Publish Expert was provided. 3 Academic norms and rules: The authors provided the Written informed consent. The CARE Checklist-2016 need to add the page number. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastrointestinal Surgery, and the manuscript is conditionally accepted.
