Scientific quality: The manuscript ID: 66061 with the following title, Current understanding of mesenchymal stem cell in liver disease, is consistent with the journal's scope and instructions. (1) Classification: One peer reviewer has given a B grade for scientific quality and another B grade for Language quality. The final recommendation by this reviewer is a Minor revision. (2) Summary of the Peer-Review Report: The peer</p> | [Y] |

reviewer has requested a general verification regarding the abbreviations mentioned in the text. Moreover, He/She has asked for some possible contraindications are there for MSC transplantation. In the end, the reviewer has asked for more information regarding the stage of liver fibrosis that could be treated by MSC transplantations. (3) Format: This manuscript has 2 tables. (4) References: a total of 69 references are cited and they are generally acceptable. However, some more references related to the implications of MSC in immune cells like T cells and Tregs could have been added to this manuscript. (5) Self-cited references: this aspect is respected. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2. Language evaluation: The language quality is acceptable (Grade B). However, Non-Native

Speakers of English Editing Certificate should be provided by native English speaker (Here: Xiaoqun Dong), not by the authors themselves. 3. Academic norms and rules: The authors must provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found by the Google/Bing search. 4.

Supplementary comments: This is an invited manuscript. The study was supported by the Municipal Natural Science Foundation of Beijing, China (Grant No. 7192085). The topic has not been previously published in the WJSC. 5. Issues raised: A) Please add page and line numbers. B) Please add a section about the limitations of MSC therapy in the treatment of liver disorders. The title is too similar to already published articles. This review article lacks some graphical figures. 6. Re-Review: Not required by the reviewer. However, the authors have to perform the requested amendments. 7. Recommendation: Conditionally accepted.
