The topic is within the scope of the WJG. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: (05232520): In general, the text is well written and structured. Further, the review presents a broad and in-depth critical analysis of data besides debating pros and cons of microbial modulation in IBS. Major concerns: Aside the difficulties of defining a microbiota as healthy or diseased, there are some aspects broadly accepted in this regard, especially concerning gut microbial ecology: resilience, resistance and diversity. Thus, authors must add this information to the text and describe the importance of each aspect in healthy and disease status. (3) Format: There is 1 figure; (4) References: A total of 142 references are cited, including 87 references published in the last 3 years; (5) Self-cited references: There are 1 self-cited references;(6) References recommendations: The authors have cited proper references. 2.Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Non-Native Speakers of English Editing Certificate. 4. Supplementary comments: The topic has not previously been published in the WJG.
