The topic is within the scope of the WJGE. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors reviewed the latest and most important researches in the field of</p>	[Y]

difficult common bile duct stones. It is good. However, the availability of experienced operator and resources needs to be considered in creating individualized treatment strategies for managing difficult biliary stones; and (3) Format: There is 1 figure. (4) References: A total of 62 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
