The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors found a highly relevant narrative review design. Approach the topics on the technique very concise and with a current and relevant scientific basis. Robust arguments for the implementation of liquid liver biopsy in the clinical routine; and (3) Format: There are 3 figures. (4) References: A total of 63 references are cited, including 15 references published in the last 3 years; (5) Self-cited references: There are 8 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations that are closely related to the topic of the manuscript, and remove other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
