(1) Classification: Grade B; (2) Summary of the Peer-Review Report: In this manuscript, the authors review the engineering nano-theranostic strategies for liver cancer, including gene therapies and photo-assisted therapies. wide range of nano-theranostic for cancer therapy. The manuscript needs to be improved in writing as follows. The authors can summarize more gene delivery vectors in the Gene delivery carrier construction part. The conclusions section is inadequate and in fact lacks of a critical overview of pitfalls and caveats of different types of treatment modalities. The questions raised by the reviewers should be answered; and (3) Format: There are 11 figures. (4) References: A total of 85 references are cited, including 49 references published in the last 3 years; (5) Self-cited references: There are 8 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
