rare case of PAMT in a young patient and performed ESD. It is interesting and brings new insights and surgical techniques. However, the questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. (4) References: A total of 40 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
