Perhaps it would be interesting for the authors to add and revise a condition that is also orphaned from clinical trials. These are the very elderly patients with inflammatory bowel disease. The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. (4) References: A total of 68 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorial office@wjgnet.com.
