(4) References: A total of 20 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. Please provide the original figure documents. Please prepare and arrange the figures
