<b>Patient Information</b>	<b>6a</b>	De-identified demographic and other patient or client specific information	<u>17/5</u>
	<b>6b</b>	Chief complaint—what prompted this visit?	<u>16-18/5</u>
	<b>6c</b>	Relevant history including past interventions and outcomes	<u>2-5/6</u>
<b>Physical Exam</b>	<b>7</b>	Relevant physical examination findings	<u>6-7/6</u>
