microbiome in acute pancreatitis. Author has elaborated the pathogenesis of AP and the possible way that bacteria may affect or be affected by AP. The questions raised by the reviewers should be answered; (3) Format: There are 6 tables and 2 figures; (4) References: A total of 108 references are cited, including 22 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations.
