psychoeducation, integrated care and telehealth to promote treatment engagement for pediatric ADHD care. The manuscript of good quality citing recent studies. However, there are some issues need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. (4) References: A total of 220 references are cited, including 33 references published in the last 3 years; (5) Self-cited references: There are 6 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
