Editorial Office's Comments

Science Editor: 1 Scientific quality: The manuscript describes a prospective study of the arthroscopic vs open ankle arthrodesis. The topic is within the scope of the WJO. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: This study compared the outcomes of open and arthroscopic ankle arthrodesis in patients with end-stage ankle osteoarthritis. Generally, this is a pretty interesting study. It has relevance to sufficient clinical practice. However, there are a few concerns that need to be addressed: The sample sizes were relatively small. Seventeen patients were excluded from further analysis and 7 patients with incomplete clinical follow-up. There were too many patients that were lost in follow-up. The included cases might not represent the target population completely. It is better to add some X-rays of typical patients. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. (4) References: A total of 37 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
