The topic is within the scope of the WJG. The corresponding author is the editorial board member of WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Treatment options for NAFLD and NASH are still limited. The authors describe some recent</p>	[Y]

findings of inhibitors of Acetyl-CoA carboxylase in animal models and clinical studies. Overall, this is a brief and up-to-date editorial on the topic, which is of high relevance to the field. A table summarizing the preclinical and clinical findings should be added. The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. (4) References: A total of 28 references are cited, including 11 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
