The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review</p>	[Y]

Report: The results are very helpful in providing directions for long term care in these patients. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 4 figures; (4) References: A total of 29 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to [editorialoffice@wjgnet.com](mailto:editorialoffice@wjgnet.com). The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Locatran Translations was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China, Hospital Research Fund from The Second Affiliated Hospital of Army Medical University. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2)

The “Author Contributions” section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (6) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6
