Science Editor: 1 Scientific quality: The manuscript describes a minireview of the hepatic ischemia reperfusion injury. The topic is within the scope of the WJH. (1) Classification: Grade D and Grade C; (2) Summary of the Peer-Review Report: The manuscript deals with the role of nitric oxide during hepatic ischemia reperfusion injury. The authors conducted a systematic review analyzing a series of possible molecular interaction mechanisms. The topic would be interesting with important repercussions on clinical practice, especially in transplantology. Sometimes the results are listed in difficult to understand way. The discussion could be developed more extensively. Furthermore, the possible clinical implications of the research have not been reported and the study limits should be highlighted. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figure. (4) References: A total of 62 references are cited, including 19 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e., those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (6) References and recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself
