further explore the progress of high myopia. Those results may be helpful for the discussion of the ongoing myopic shift in childhood. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 3 figures; (4) References: A total of 22 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
