Science Editor: 1. Scientific quality: This review summarizes the role of circulating tumor cells (CTCs), the major tools and techniques used for CTC detection, as well as important findings of clinical studies regarding CTCs in colorectal cancer and their clinical implications. The topic is within the scope of the WJCO. (1)

Classification: Grade C (a single Reviewer); (2) Summary of the Peer-Review Report: The detection of circulating tumor cells (CTCs), or liquid biopsy, presents several advantages over traditional tissue biopsies. They are non-invasive, can be used repeatedly, and provide more useful information on metastatic risk, disease progression, and treatment effectiveness. This review highlights the important role of CTCs in colorectal cancer and summarizes recent progress towards precise detection of CTCs in blood of colorectal cancer patients. Taking into consideration the liquid biopsy is a very promising sample, this review is particularly interesting and useful for oncologists. Moreover, the manuscript is well-written, but needs selective improvement. In this context, the questions raised by the reviewer should be answered; (3)

Format: There are 3 tables and no figure. All tables are informative; however, they need more editing by the authors; (4)

References: A total of 77 references are cited, including only 4 references published in the last 3 years. The authors have cited several important papers relevant to their study; however, the reference list needs to be expanded, in order to include more papers published in the last years; (5) Self-cited references: There are no

self-cited references. The self-referencing rate is less than 10%, which is acceptable; (6)References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2. Language evaluation: Classification: Grade B (a single Reviewer). According to the Reviewer's report, minor language editing and grammar correction are only needed. The corresponding author claims that the manuscript has been reviewed for clarity by a colleague of the authors whose native language is English; however, no such certificate is provided along with the manuscript; 3.Academic norms and rules: No Conflict-of-Interest statement is included in the manuscript; moreover, the authors did not provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found by the Google/Bing search. 4.Supplementary comments: This is an invited manuscript. No financial support is mentioned.
