Science Editor: 1 Scientific quality: The manuscript describes a minireview of the challenges in hyperglycemia management in critically ill patients with COVID-19. The topic is within the scope of the WJCCM. (1) Classification: Two Grades C; (2) Summary of the Peer-Review Report: The manuscript is generally well written and conveys some clear-cut messages. However, considering that the topic is novel and knowledge is rapidly emerging, the authors could consider adding a few more references contributing to up-to-date information. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 65 references are cited, including 58 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Two Grades B. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not

	previously been published in the WJCCM. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; and (2) Please add table/figure to this review. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
