comments. The authors should revise minor grammatical errors. 3) Format: there are 2 figures and 2 tables in the manuscript. The quality is acceptable. 4) References: a total of 26 references are cited, including 10 references published in the last 3 years; 5) Self cited references: there are not any self-cited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated 6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). A language editing certificate by International Science Editing was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, Institutional Review Board Approval Form or Document, and the Non-Native Speakers of English Editing Certificate. It is not clear if the Authors followed all the STROBE Statement checklist when preparing the manuscript.

The signed informed consent is in Chinese language, and according to the declaration of the Authors in the manuscript, the patients included in the study did not sign the informed consent as the analysis used anonymous clinical data that were obtained after each patient agreed to treatment by written consent. No academic misconduct was found by the Google/Bing search. 4

Supplementary comments: This is an unsolicited manuscript. The study did not receive any funding. The specific topic has not previously been published in the WJGS. 5

Issues raised: (1) The legends in the figures and tables should include full form of the abbreviations used. (2) Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text (and directly before the References); (4) Please obtain permission for the use of picture(s). If an author of a submission is re-using a figure or figures published elsewhere, or that is copyrighted, the author must provide documentation that the previous publisher or copyright holder has given permission for the figure to be re-published, and correctly indicate the reference source and copyrights.
