The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors attempted to find a possible mechanism of Cistanche deserticola in the treatment</p>	[Y]

of chronic constipation and explore the SCF/c-kit signaling pathways in the role of *Cistanche deserticola* treating constipation. It showed that the c-kit/SCF signaling pathway may be an important mechanism of the therapeutic effect; and (3) Format: There is 1 table and 5 figures. (4) References: A total of 26 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (7) The scientific quality can't meet the requirement of WJG. 6 Recommendation: Transferring to the WJCC.
