The topic is within the scope of the WJT. (1) Classification: Grade B, C and D; (2) Summary of the Peer-Review Report: Nice design study, congrats. Authors should add more about the description of cases, The questions raised by the reviewers should be answered; (3)</p>	[Y]

Format: There are 4 figures; (4) References: A total of 33 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade A, B and B. The authors are native English speakers. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJT.

5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Recommendation: Conditional acceptance.
