| Patient Information | 6a | De-identified demographic and other patient or client specific information | <u>L10/P4</u> |
| | 6b | Chief complaint—what prompted this visit? | <u>L10/P4</u> |
| | 6c | Relevant history including past interventions and outcomes | <u>L14/P4</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>L1/P5</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>L6/P5</u> |

| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>L20/P5</u> |
