The topic is within the scope of the WJCC. (1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: The report also includes the potential</p>	[Y]

mechanism of abscess formation in these three patients with mucinous ascending colon adenocarcinoma. This is an interesting case report. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 3 figures; (4) References: A total of 7 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors didn't provide the written informed consent of treatment. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Science and Technology Fund Foundation of Guizhou, the Science and Technology Fund Foundation of Zunyi City. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions"

section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
