PD-1-inhibitor-induced, new-onset autoimmune diabetes mellitus. After controlling her blood glucose, she was treated with daily insulin by subcutaneous injection. She was allowed to continue anti-PD-1 therapy and she managed to obtain some therapeutic efficacy. No suggestions by the Reviewer exist. (3) Format: There are 4 table and 3 figures. The figures are of good quality. The tables are well-structured and informative; (4) References: A total of 55 references are cited, including 42 references published in the last 3 years. The literature is well-reviewed; the authors have cited several important papers relevant to their study; (5) Self-cited references: There are no self-cited references. The self-referencing rate is less than 10%, which is acceptable; (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
