The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The authors have presented an interesting</p>	[Y]

case. Discussion needs major changes. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 2 figures; (4) References: A total of 17 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The authors need to fill out the CARE Checklist (2016) with page numbers; (4) To obey the publication ethics and improve the protection of all patients' rights to privacy, the authors should provide the informed consent form on which the patient's name, address, birthday, address, ward, bed number, hospital number and other private information are obfuscated. 6 Recommendation: Conditional acceptance.
