Classification: Grade B; (2) Summary of the Peer-Review Report: The Authors demonstrated that hypoxia-inducible factors induce CBX8 transcription by combining with the promoter of CBX8. CBX8 is a key gene which is regulated by HIF-1a, and could IRS1/AKT pathway. CBX8 maybe a promising therapeutic strategy for pancreatic cancer; (3) Format: There are 6 figures; (4) References: A total of 15 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
